5. HEALTH HAZARD INFORMATION

- Inhalation:** Inhalation of high concentrations of vapor may result in irritation of eyes, nose and throat, headache, nausea, and dizziness
- Skin Contact:** Repeated or prolonged contact can cause redness, irritation and scaling of skin (Dermatitis). Adverse skin effects should be prevented by normal care and personal hygiene
- Eye Contact:** May irritate eyes
- Ingestion :** Low order toxicity causing irritation of the stomach and intestines which results in nausea and vomiting

6. EMERGENCY AND FIRST AID MEASURES

- Inhalation:** Remove to fresh air. Give oxygen if breathing is labored and seek medical advice. Avoid casual breathing. Signs of over exposure are dizziness and nausea.
- Skin Contact:** Skin contact can produce irritation, or itching of the skin. Remove contaminated clothing Wash with soap and plenty of water. Seek medical attention if irritation persists.
- Eye Contact :** Contact with eyes can produce burning sensation. Irrigate with water immediately, continue flushing eyes with water for 15 minutes. Seek medical attention if irritation persists.
- Ingestion:** Rinse mouth; dilute with milk or water and consult a physician immediately. Do not induce vomiting. Never-give anything by mouth if victim is unconscious, is rapidly losing or is convulsing

7. HANDLING AND STORAGE

- Handling:** Follow good industrial practice as to housekeeping, Avoid inhalation, contact with skin and eyes. Wear splash goggles and oil-resistant gloves. Provide good ventilation.
- Storage:** Containers should be kept closed in order to minimize contamination. Store in a cool, dry, well ventilated place protected from light. Keep away from extreme heat and from freezing conditions and away from all sources of ignition
